

Fazenda initially used Zoho Connect and Zoho Cliq in tandem to automate and run their operations, before eventually discovering and leveraging Zoho Creator.



Each rodizio location hosts the application on a tablet device, placed in the reception area.

The application assists people who provide services to the restaurants in various ways. This includes stakeholders like contractors, suppliers, and head office staff.

The application handles:

Time logging

It logs the hours that stakeholders are on site. This information is used to gauge payments based on services rendered.



Compliance with health and safety standards

Fazenda has high standards for health and safety. This module of the Creator application requisitions health and safety declarations.



Adherence to regulations

It walks stakeholders through pertinent regulations, so that business processes are performed according to regulations.



Access for stakeholders

The application accounts for everyone who is at Fazenda at any given time, tracking the whereabouts of guests, to be retrieved instantly if required.
